These web sites owner has copied my web site layout, graphics and texts located at <http://www.peneana.com>, he has changed some colours and placed all my copyrighted works on his web pages without my authorization. According, his actions are in violation of United States copyright law and I request Google either remove or disable access to the web sites above detailed.

Please note that in the html source code of the web pages at <http://www.penes-largos.com> and <http://www.dificultades-sexuales.com> , you can view the text "Peneana.com" into the ALT tags of the logo image. This prove that these web sites owner has stolen my web pages and all my copyrighted work.

I have a good faith belief that use of the copyrighted materials described above on the allegedly infringing web pages is not authorized by the copyright owner (me), its agent, or the law.

I swear, under penalty of perjury, that the information in the notification is accurate and that I am the copyright owner or am authorized to act on behalf of the owner of an exclusive right that is allegedly infringed.

Since you have now been put on notice, you do now have actual knowledge that the material on your system is infringing. Failure to act expeditiously to remove or disable access to the material strips you of the protections for OSPs provided by the DMCA.

I am not seeking to become involved in litigation, but I will take all necessary measures to protect my intellectual property rights. I presume that you would agree that we can resolve this amicably.
