1. The work in question is the entire website [www.vintagelightingfixtures.com](http://www.vintagelightingfixtures.com). The website was originally designed by my company, SG Design Group and is presently being used by Vintage Lighting Fixtures without our consent or authorization and without payment in full for past graphic and website services rendered.

You should be aware that the Rockland County, NY DA's Office is currently investigating the Owners of

[Vintagelightingfixtures.com](http://www.vintagelightingfixtures.com) for accepting payment and not delivering. The Rockland Journal News and ABC Online have covered the story which tells of the owners' [REDACTED], disappearing from their store in Nyack, NY leaving behind many upset customers who paid in full for their merchandise.

Further, I have recently filed charges of Theft of Services, and Criminal Possession of Computer Material and Unlawful Duplication of Computer Data, respectively under NY State Penal Law, PL 165.15 (11), PL 156.35 and PL 156.30 (11); two of which I believe are felonies in the State of NY.

6. I swear, under penalty of perjury, that the information in the notification is accurate and that I am the copyright owner or am authorized to act on behalf of the owner of an exclusive right that is allegedly infringed.
