Per your instructions regarding copyright infringement, I am providing the following information. On Saturday March 1, 2003, I typed in a search on <http://www.google.com> for "dog bows". Via that search, I decided to click on the word "images" on the resulting page where I was directed to <http://images.google.com/images?hl=en&lr=&ie=UTF-8&oe=UTF-8&q=dog+bows&sa=N&tab=wi> thereby I came upon a shock to see a competitor selling MY dog bows and using a photo of MY dog to sell the items. As per your request, the offending website's URL located in green lettering is "ziggysboutique.homestead.com/xmas.html"

She has stolen the photos from my website which very clearly states the items are all copyright by me and my company.

Let it be known that I can also access this webpage by a search from <http://www.google.com> by inputting "Ziggy's Boutique Xmas".

I have attached photos of the infringing items as shown direct from my website. I did infact take the photos myself with my digital camera. I do still own the dog that is shown and do have proof of this via AKC paperwork and an implanted microchip. I also have proof on my computer photo program of the exact date these photos were taken.
