I am an attorney with the law firm of Hughes & Luce, and I am writing on my own behalf to report **three** copyright violations that are currently indexed on Google when a search is done for my name.

**Section 1 – Copyrighted Material.** There are two pieces of material that are copyrighted by me. First, an article of mine appears at <http://www.enterstageright.com/archive/articles/1001/1001flight93.htm>. Second, some blog postings of mine appeared at <http://stuartbuck.blogspot.com>.
