LEGAL MATTER****Re: Unauthorized news group posting**

Dear Google Legal Counsel:

Wind River Systems, Inc. ("Wind River") is submitting this notice of infringement under 17 U.S.C. § 512. The format of this letter is pursuant to the requirements set forth by Google (<http://www.google.com/dmca.html>).

1. The copyrighted work that has been infringed upon is the Tornado(R) integrated development environment, the VxWorks(R) operating system, and additional software products included in each, including the technological measures that control access to these works and effectively protect the rights of Wind River in these works.

2. A news posting with the Message ID 3E8E98F7.1A8561A4@ath.forthnet.gr was made to the newsgroup "comp.os.vxworks" on Sat, 5 Apr 2003 08:45:34 (GMT) by an entity having the email address [REDACTED]. This posting includes proprietary information of Wind River, in the form of key codes (25 characters following "SN:" in the posting) useful to circumvent a technological measure that controls access to, and effectively protects the rights of Wind River in, the Tornado and VxWorks computer programs, the copyrights for which are owned by Wind River.
