A) Text which has been simply cut and pasted onto the <http://www.1-barefoot-coral-calcium-supreme.com/alka-slim.htm> site, (note the mistake we made, the missing "of" which they didn't even bother to fix):

"Developed by Dr. M. T. Morter Jr., Alka-slim is a revolution in Weight-Reduction and dietary supplementation. It is the only weight reducing, health enhancing product specifically designed to alkalize and energize at the same time! Two scoops of Alka-Slim contains only 81 calories; fruit juices add approximately 100 calories."

"Dr. Ted Morter, Jr. is an internationally recognized authority on healthcare. A healthcare specialist for more than 30 years, he is best known by the general public for his best-selling books on health and nutrition, such as *Your Health, Your Choice* and *An Apple a Day*.

One [OF] (missing in their text as well) Dr. Morter's most innovative developments is *Alka Slim*, a product that is specially formulated to aid in weight loss and increase body alkalinity for better health, while providing nutrition for energy. However, Dr. Morter has devoted his life to more than just the public arena to improving healthcare in America. For example, he is well known to health professionals for numerous magazine articles and three books he wrote with different health concepts in mind. These books include: *Chiropractic Physiology*, *Correlative Urinalysis*, and *The Healing Field*.

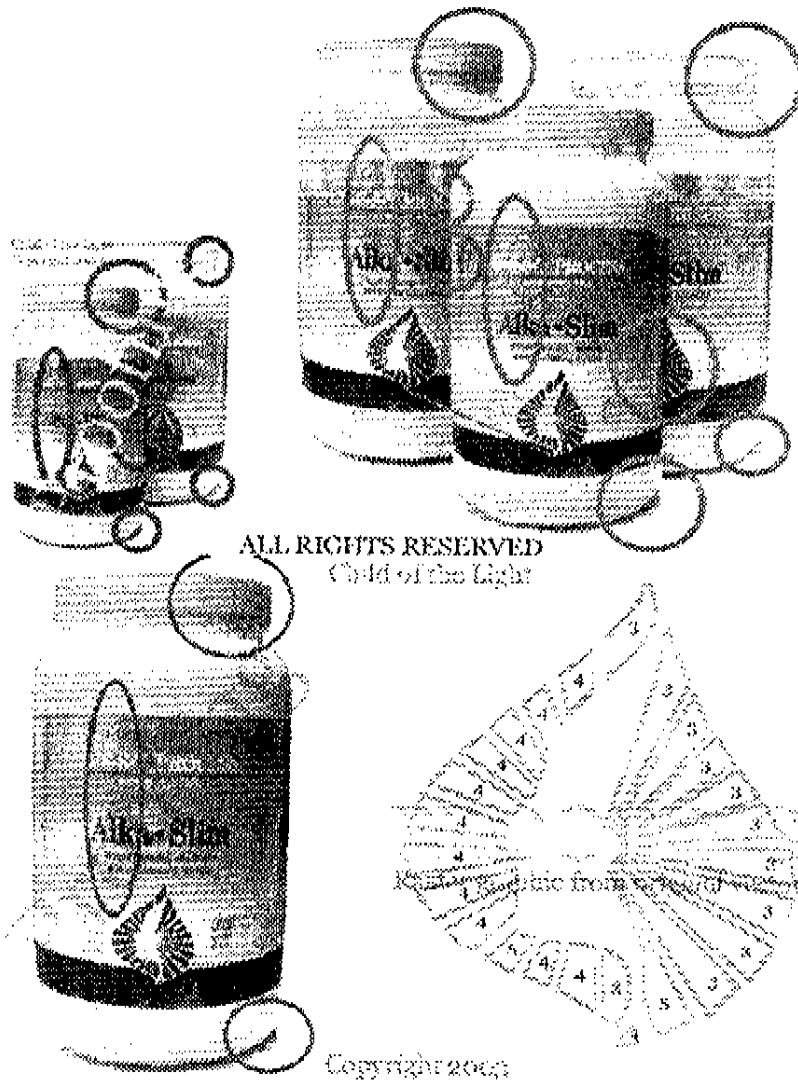
