We have been unable to contact the owner/administrator as it is a Tonga domain and they refuse to release such information. Nor is there any contact info or addresses anywhere on the site -- the site is basically a doorway site for www.spanishpropertyworld.com which is a doorway site for www.interentia.es. It's a clever and complicated scenario.

However our only concern is the copyrighted works on our pages which (as far as we know) are only infringed by the doorway www.fuerteventura.to site. We cannot get in touch with them for good reason no doubt.

I have a good faith belief that use of the copyrighted materials described above on the allegedly infringing web pages is not authorized by the copyright owner, its agent, or the law.
