This Digital Millennium Copyright Act complaint is on behalf of my client, Arcadia Software Development Corporation. The copyrighted work at issue is the software: Arcadia PowerButton v3.0, which is developed and sold by my client.

Last week, a hacker unlawfully posted a full version of the said software -- together with a valid activation serial number -- on a several East Asian languages sites.
