I'm the author and publisher of an e-book on CD-ROM. The infringing party has posted my ENTIRE book on his web site; this means graphics as well. I have contacted them, but they have not responded. I have also contacted their registrar and domain host and they are looking into the issue, but have done nothing, yet. I'm strongly considering legal action.

You can verify that this is my book at <http://sab.jcsm.org> and <http://az.jcsm.org>. I have three editions and ISBNs for each one. Furthermore, the U.S. Copyright Office has a copy on file with them as of March 2003.

Please remove your link to <http://www.skepticsannotatedbiblecorrected.com> and disallow any links to their web pages. They are exposing my book and my book is not free. Furthermore, they plainly admit on their site that I wrote the book. They gave me credit in word, but they break the law and post the entire book and my images.
