Dear Google Team:

This letter will respond to your email of May 18, 2004 and supplement our letter dated the same day, in which I wrote to you on behalf of our client Matsunoki Group, Inc., d/b/a Haiku Houses. Although my letter complied with the requirements of Section 512(c) of the Copyright Act, I will attempt to provide the information in the format requested in your email.

1. Identify in sufficient detail the copyrighted work that you believe has been infringed upon.

The copyrighted work at issue is text, images and drawings that appear on www.kokorocountryhouses.com. The website impermissibly copies images, text and architectural designs owned by my client and used on its website www.haikuhouses.com and in her catalog "Haiku Houses: Country Houses of 16th Century Japan." In fact, nearly every image on kokorocountryhouses.com belongs to my client. In addition, there are numerous places on that website where text is paraphrased from my client's works in violation of its copyright.

2. Identify the material that you claim is infringing upon the copyrighted work listed in item #1 above.
