(trading as Agents Oracle) and request removal of a number of sites that are providing and displaying copyrighted information that has been taken from our site and is being provided to them by a third party, <http://www.slginmolink.com> (Administrator - [REDACTED] Email - [REDACTED]@[REDACTED].com or [REDACTED]@[REDACTED].com).

We are a subscription based service which has been providing information to the real estate industry for more than 18 months. It has recently come to our attention that a rival service has been set up which has copied our information and is selling it to various companies. Verification of this infringement may involve access to both our system and to the system of [www.slginmolink.com](http://www.slginmolink.com).
