They denied it, and have since modified the page. According to copyright law the modified copy is still an infringement. The original infringement broke the following Internet copyright laws:

- Layout
- Graphics
- Text

The page currently online is infringing upon text and layout, the modified text is still saying the same thing in the same order. The page shows up in the rankings on Google in front of our site now on the following search query's:
