This is to request that you please remove a link to a graphic image that we own. It is currently linked to a company that is our customer, but which is not authorized to use the image.

High Purity Northwest, which sponsored the unauthorized Meissner graphic image in the Google links, is not clear as to how the link was established, but has agreed to remove all unauthorized Meissner images from its website. While the infringing image has been removed, the Google links have survived, and we want them removed from Google immediately.
