The material on the site is false and inflammatory and utilizes copyrighted photos taken from a previous version of my website. I am a Vietnam veteran with 16 months of service in Vietnam validated by my DD214. I do not claim to be a Special Forces Veteran; I am an Ex Special Operations Veteran, The United States Army Security Agency.

This site is extortion based and has used Google to advance its goal to destroy my reputation and my business. Even a quick check of their links will show you how false their assertions and how dangerous these people are. I recommend that you remove all references to their site.
