Please be advised that Universal City Studios Productions LLLP and its affiliated companies (collectively Universal) are the exclusive owners of copyrights and other intellectual property rights in many motion pictures and television programs, including the title(s) listed below (the Universal Properties). Universal diligently enforces its rights in its motion pictures and television programs.

It has come to our attention that unauthorized copies of the Universal Properties are being offered from the website listed below. Axess Communications is the service provider for this website, and we believe that Axess Communications or a downstream service provider who purchases this connectivity from Axess Communications is providing the Internet access of the person responsible for such activity (the Infringer).
