This letter is to inform you of alleged infringement as required by your Digital Millennium Copyright Act notification policy.

Darkside Productions, Inc. has since 1997 been the operator of the website located at www.eros-guide.com and features advertising for adult entertainers worldwide. The site operates through a large number of 'Eros' related domains which are owned by Group Kaitu, LLC and which are licensed exclusively for Darkside Productions, Inc's use.

In addition, Group Kaitu, LLC is the owner of several US trademarks, including Service Mark Registration No. 2549369 for the mark EROS GUIDE and United States Service Mark Registration No. 2793831 for the mark EROS, both for the operation of Internet Websites.

1. Identify in sufficient detail the copyrighted work that you believe has been infringed.

The copyrighted work in question is the text, photos, and other graphic components of advertisements which appear on our eros-guide website. The infringing material in question has been copied directly from our site and even retains our trademarked name and photo watermarks.

2. Identify the material that you claim is infringing the copyrighted work listed in item #1 above.

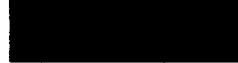
