This leads me to believe that the course of action taken by companies were for mere profit. Companies & Affiliates are advised and aware of the various text created by the various authors.

No other authors work can support or substantiate the text used by any company and the infringement named in this document, pursuant to filing a lawful suit of this infringement.

Products made for profit in cases of infringement constitute a willful act to commit fraud in which such acts may be investigated and persecuted by the U.S. Attorney, Department of Justice. In the matter of this case the Attorney General's Office has received numerous complaints to investigate these counterfeit products.

Mediation has been an option offered by me while dealing with the pursuit of this claim. Companies & Affiliates have failed to negotiate any suitable settlement.

Infringement fines can be determined to a maximum benefit of \$250,000.00 dollars for each item infringed upon, each specific product and variation of any given product. So far Companies & Affiliates Product infringement has produced over 20 - 30 such items of infringement.
