## 5. Statement

I have a good faith belief that use of the copyrighted materials described above on the allegedly infringing web pages is not authorized by myself being the copyright owner.

Copyright was established when I created the photographic images and text description of myself in 2001.

As the creator and author of these works I granted Amigos de Punto de Encuentro S.L. limited authority to display these images and text on their dating web site based on the understanding that I could revoke that authority immediately when required.

However I have now contacted them on many occasions including as recently as the 10<sup>th</sup> of February, 2005 and 18<sup>th</sup> February, 2005 to inform them I no longer wished them to make this information public on their web site and that I had withdrawn permission to display such as the sole owner of the copyright in the work.

Despite stating on their web site that *"the advert of a person who communicates to us that she has found a couple, is deleted from the Web Page in less than 2 hours"* de Punto de Encuentro S.L. have failed to remove the material in which I have copyright and as such are in breach of my copyright.

Therefore I request that Google block access to my copyrighted material and immediately remove any cached images which would result in my copyrighted material persisting on the internet.

I swear, under penalty of perjury, that the information in the notification is accurate and that I am the copyright owner and as such have an exclusive right that is infringed.
