I would like to bring to your attention a copyright violation of intellectual property belonging to Thinkbox Interactive LLC. I am providing the details you have requested as per the document <http://www.google.com/dmca.html>

1. The copyrighted work at issue is the text that appears on the web site www.infobeagle.com. The person in question has taken the entire site content including web pages, supporting JavaScript files and cascading style sheets from the infobeagle.com web site and made very minor cosmetic changes and published the work. It is a blatant duplication of an entire collection of copyrighted work from source code, content, look and feel etc.
