Our firm represents Goldon Fishing Expeditions, Inc ("Goldon"). On behalf of Goldon, the following is a notice of claim of copyright infringement and a request for relief pursuant to Section 512(c) of The Digital Millennium Copyright Act, (17 U.S.C. §512(c)). The claim of infringement is against Clear Waters Angling ("Clear Waters").

I have laid out the corresponding pages on Clear Waters' website with the pages on Goldon's website so that you can easily see the material that has been copied from Goldon's site. You will note that in most cases, the text from Goldon's website has been copied exactly on Clear Waters' website. Other corresponding pages show how the lay out of the page has been copied. Additionally, pictures from Goldon's website have been copied and used on Clear Water's website. I have captured screen prints of all corresponding web pages, but you can see clearly if you pull up each website and go to the URL's I have supplied you in the attached chart.

The unauthorized duplication of Goldon.com content and meta-tags has affected our client's rankings on Yahoo, and Goldon.com may have been removed completely as being identified as a mirror itself. Please remove Clear Waters' website upon receipt of this notification. If Clear Waters website is not currently accessible through Google, please be on alert, and remove the website immediately should it appear on Google in the future. I appreciate, in advance, your attention to this matter.
