I sent the original to Blogger by FedEx. It arrived on May 16.
According to
FedEx records, it was signed for by [REDACTED] The Proof of
Delivery is
attached.

This morning, I noticed that the material is still posted on Blogger. I
know

that several other people have complained about the site's stated
policy of
being "one-half plagiarized." I believe this incident is especially
blatant

because a 675+ word article was posted, and a comment giving me credit and a

link back to the article was deleted by the offending party.

I believe this is a violation of the Blogspot.com
<<http://Blogspot.com>> Terms of Service, Section
4, second paragraph, point e. I request that this material be
removed
immediately.

I have not gotten a response about the Notice of Infringement.
When can I
expect a reply?
