18 illustration, and not in limitation, all Internet Services
19 Providers, including GOOGLE.COM, be, and hereby are enjoined
20 from disseminating via the Internet or otherwise any information
21 about Clifford Kaplan; and

22 **IT IS FURTHER ORDERED** that all references pertaining to
23 Clifford Kaplan currently displayed on any website operated
24 and/or controlled by CHARLES H. BRUCE individually and d/b/a
25 NATIONAL CHECK FRAUD CENTER, be removed pending further Order of


