I am filling this DMCA report regarding the matter of copyright infringement.

It has come to my attention that MCS machine control services, Inc. The owner of

Which operates out of Texas, USA. Has been infringing our rights of ownership and copyright over 2 different photographs that it persists to place on its websites. I have approached the owner of the sites, [REDACTED] (MCS owner) and asked him politely to remove the photos - he refused. However his theft of our images of our products (explained below) has become more widespread too the extent he has now placed 2 pictures of our images on 5 pages across 3 websites.

1. We have the original Photographs:
