1. The copyrighted work at issue is the text that appears on the web site [www.infobeagle.com](http://www.infobeagle.com). The person in question has taken the entire site content from all pages of the infobeagle.com web site making very minor cosmetic changes, and then publishing the work as their own. It is a blatant duplication of an entire collection of copyrighted work with no reference to the original author or originating website. In addition, this duplication has been made without the consent of Thinkbox Interactive LLC.
