Pursuant to your e-mailed instructions, I am writing to seek removal of 2 of my copyrighted photos from the the-bun.blogspot.com - specifically from its August 5, 2005 entry.

1. There are 3 photos of Elton John and John Lennon with the caption, "**ELTON TO RELEASE EXPANDED VERSION OF 'CLASSIC ALBUM'**:" supporting that entry on the August 5, 2005 page: a black-and-white and 2 color. The two color shots are mine.

Though they can only show up on the current main page and an August 5, 2005 page, it is possible they may not be on the current main page by the time you receive this request because of new daily postings replacing it.

Both photos were taken directly from my web site - <http://www.bobleafe.com/> - a site with multiple mentions of copyright, including a separate copyright page.

If you click for the addresses of those 2 photos, you will see that that are identical to the ones on my site. Here are the 'images' addresses as they appear on both my site and on the-bun.blogspot.com:

2. As mentioned above, the 2 photos are CURRENTLY on 2 pages of the blog, though they may be off the updated page by the time you read this. Here are their URL's:

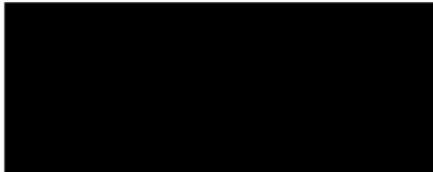
