Google must remove all links that appear at the bottom of the Google Groups pages when you do a search for the name "Philip Bartlett" "Bartlett" or "Phil Bartlett" or "P Bartlett" that result in the following link at the bottom of the search result page, to a DMCA complaint filed on November 19, 2003. The reason why Google must remove this link is because the link contains Copyrighted materials on the complaint that were not expressly authorized for reproduction and are effectively reposting what was taken down from Google Groups. Google may replace that link with a link to this complaint, only provided that Chilling Effects does not link the two complaints to each other. All references to first and last

name and first and last initials must be removed from the complaint, as well as address information.
