We have written to you in the past with respect to intellectual property matters. Unfortunately, we have to write to you again. In this matter, we represent Religious Technology Center ("RTC"), Bridge Publications, Inc. ("BPI"), Church of Scientology International ("CSI") and the L. Ron Hubbard Library, non-profit religious corporations.

There are a number of works belonging to our clients in your archive, all of which are set forth below.
