Sir/Madam:

I write to complain about Blogger blogs that have copied material from a website owned by one of my clients.

1. The copyrighted work at issue is text that appears on the website Mesotheliomaweb.org.

5. I have a good faith belief that use of the copyrighted materials described above on the allegedly infringing web pages is not authorized by the copyright owner, its agent, or the law.

6. I swear, under penalty of perjury consistent with United States Code Title 17, Section 512, that the information in the notification is accurate and that I am the copyright owner or am authorized to act on behalf of the owner of an exclusive right that is allegedly infringed.

Some of these blogs copy only two paragraphs, and I normally wouldn't complain about only that much copying, but here they actually copy the phone number from our site and more or less represent themselves as us, which is not good. Additionally, none of these blogs looks like it was set up to share information. It's obvious that the bloggers thought they could make money from ads targeting the word "mesothelioma" and stole our content solely for that reason.
