Due to the criminal nature of their websites it is no doubt on purpose that they do not want to be known. A word of warning: in addition to giving away our software registration numbers and thousands of other software title serial numbers/unlock codes, the infringing sites contain adult material and many viruses.

5. I have a good faith belief that use of the copyrighted materials described above as allegedly infringing is not authorized by the copyright owner, its agent, or the law.

6. I swear, under penalty of perjury consistent with United States Code Title 17, Section 512, that the information in the notification is accurate and that I am the copyright owner or am authorized to act on behalf of the owner of an exclusive right that is allegedly infringed.
